4.	The ORGANIZER will reimburse the CONTESTANT's travelling expenses and pay him N/A % of the amount provided for in clause II.2, where the CONSTESTANT is present at the official weight-in and his opponent or the substitute contestant cannot fight as schedule.				
5.	Where he his unable to participate in the program of the sports event for medical reasons, the CONTESTANT agrees to provide a certificate to that effect and undergo a medical examination by a physician designated by the R A C.J.				
6	Where the opponent is unable, for any reason whatsoever, to fight on the day of the program of the sports event, the CONTESTANT agrees to fight a substitute opponent chosen by both parties and authorized by the R.A.C.J. no later than 24 hours before the beginning of the first bout schedules on the program.				
7.	The Parties reserve the right to terminate this agreement at any time for all legal purposes where: a) the parties so consent in writing b) the CONTESTANT is declared unfit to light as a result of the medical examinations required under subparagraphs 2 and 3 of the lirst paragraph of section 159 of the regulation respecting combat sports c) if the CONTESTANT is disqualified after being tested positive on an anti-doping control test refuse or neglect to take the said control as stipulated in the section 148.1 of the Act respecting safety in sports (R.S.Q., c. S-3.1) d) either of the parties commits a serious breach of any of his obligations under this agreement or it is impossible for one of the parties to accomplish the object of this agreement. the event is officially cancelled.
